The "Explanations" section of each chapter presents my analysis of the examples in that chapter. The most effective way to use the book is to read each chapter when that topic is covered in your civil procedure course and to try to answer the questions yourself, based on my introductions and your reading for class. To keep yourself honest, write out your own analysis of each example, if only in a few sentences, before comparing it to mine. You may also want to review the chapter again after class coverage or discuss with your civil procedure professor any issues that you don't fully understand.
